

How to get there		Radisson Blu Hotel, Zurich Airport
	from Airport	The hotel is located between the Arrival / Check-in 1 building and the main airport building Airport center / Check-in 3. The subterranean walkway to access the hotel is found between level 0 of the Airport center and Check-in 1.
	by train	Connections from Zurich Main Station to the airport's train station, Zurich Flughafen, leave about every 5 minutes. To get to the hotel from the train station, you go up to the 1st level of Zurich Airport and walk about 3 minutes in the direction of Check-in 1. The hotel is situated on your right hand side.
